The annual fundraising event takes place each spring and is held at Rice University and has raised a total of \$250,000 to date. Funds from the Pet Walks have supported, among other things, post-Hurricane Harvey animal wellness efforts and contributed to the completion of the cat adoption and kennel area in BARC’s adoption center.
