

# Privacy Policy

This privacy policy has been compiled to better serve those who are concerned with how their 'Personally identifiable information' (PII) is being used online. PII, as used in US privacy law and information security, is information that can be used on its own or with other information to identify, contact, or locate a single person, or to identify an individual in context. Please read our privacy policy carefully to get a clear understanding of how we collect, use, protect or otherwise handle your Personally Identifiable Information in accordance with our website.

## What personal information do we collect from the people that visit our blog, website or app?

When ordering or registering on our site, as appropriate, you may be asked to enter your name, email address, phone number or other details to help you with your experience.

## When do we collect information?

We collect information from you when you fill out a form or enter information on our site.

## How do we use your information?

We may use the information we collect from you when you register, make a purchase, sign up for our newsletter, respond to a survey or marketing communication, surf the website, or use certain other site features in the following ways:

## How do we protect visitor information?

Our website is scanned on a regular basis for security holes and known vulnerabilities in order to make your visit to our site as safe as possible.

We use regular Malware Scanning.

We do not use an SSL certificate

- We only provide articles and information, we never ask for personal or private information like email addresses, or credit card numbers.

## Do we use 'cookies'?

We do not use cookies for tracking purposes

You can choose to have your computer warn you each time a cookie is being sent, or you can choose to turn off all cookies. You do this through your browser (like Internet Explorer) settings. Each browser is a little different, so look at your browser's Help menu to learn the correct way to modify your cookies.

If you disable cookies off, some features will be disabled that make your site experience more efficient and some of our services will not function properly.

We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others' rights, property, or safety.

However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other uses.

## California Online Privacy Protection Act

CalOPPA is the first state law in the nation to require commercial websites and online services to post a privacy policy. ### COPPA (Children Online Privacy Protection Act)

When it comes to the collection of personal information from children under 13, the Children's Online Privacy Protection Act (COPPA) puts parents in control. The Federal Trade Commission, the nation's consumer protection agency, enforces the COPPA Rule, which spells out what operators of websites and online services must do to protect children's privacy and safety online.

We do not specifically market to children under 13.

### Fair Information Practices

The Fair Information Practices Principles form the backbone of privacy law in the United States and the concepts they include have played a significant role in the development of data protection laws around the globe. Understanding the Fair Information Practice Principles and how they should be implemented is critical to comply with the various privacy laws that protect personal information.

### In order to be in line with Fair Information Practices we will take the following responsive action, should a data breach occur:

- Within 7 business days

We will notify the users via in site notification

- Within 7 business days

We also agree to the individual redress principle, which requires that individuals have a right to pursue legally enforceable rights against data collectors and processors who fail to adhere to the law. This principle requires not only that individuals have enforceable rights against data users, but also that individuals have recourse to courts or a government agency to investigate and/or prosecute non-compliance by data processors.

### CAN SPAM Act

The CAN-SPAM Act is a law that sets the rules for commercial email, establishes requirements for commercial messages, gives recipients the right to have emails stopped from being sent to them, and spells out tough penalties for violations.

### Cookies Policy

#### Consent

By using our website, you consent to the use of cookies in accordance with this Cookies Policy. #### What are Cookies?

A cookie is a text-only string of information that the Services transfer to the "cookie" file of the browser you are using so that the Services can recognize your computer when you re-visit and remember certain information about you, such as which pages you visit, choices you make from menus, and the time and date of your visit.

#### Types of Cookies

There are two main types of cookies:

---

(i) Session cookies: these are temporary cookies that expire when you close your browser. Session cookies allow the Services to recognize your computer as you navigate between pages during a single browser session, allowing you to use the Services most efficiently.

(ii) Persistent cookies: these are stored on your computer between browsing sessions until they expire or are deleted. They allow the Services to remember your preferences and tailor services to you.

## Information Collected by our Analytics Software

Some of the cookies we use are 'analytical' cookies. Our analytics software (Google Analytics and /or SiteImprove) allows us to recognize and count the number of visitors and to see how visitors move around the Services when they are using the Services. This helps us to improve the way the Services work, e.g., by making sure that users are finding what they need easily. The following types of information are collected by our analytics software:

- User's demographic information, e.g., language preference and location (city, country/territory, continent, sub-continental region).
- User's behavior, e.g., whether the user is a new or returning visitor, the frequency of visits/date of last visit.
- User's technology, e.g., operating system, network/service provider (ISP and network host).
- Mobile information, e.g. whether the user accessed the Services via a mobile device and, if so, the type of device (brand, service provider, operating system and input selection method).
- Traffic source, e.g., direct (i.e., the user typed in the URL themselves) or referral (i.e., the user clicked on a link) and for referral traffic, the traffic source (search engine or link); also the Google search term (if applicable) that resulted in the link to the Website.
- Content viewed, e.g., pages, files, and directories clicked on, landing pages/exit pages and search words (if any) used on the Website.

## Disabling cookies

If you do not want information collected through the use of cookies please disable them by following the instructions for your browser.
