I, Theodore A. Griffinger, Jr., declare:

1. I am counsel for Interested Party Global Generation Group, LLC in this action. I have personal knowledge of the facts set forth below and, if called as a witness, could and would competently testify to the facts stated herein.

2. On or about August 30, 2018, I received an electronic copy of The SRA Investor Group’s Proposed Alternative Distribution Plan, a true and correct copy of which is attached hereto as **Exhibit A**.

3. In September 2018, I participated in meet and confer sessions with other parties to this action to discuss the proposed plans of distribution which had been submitted by the Securities and Exchange Commission and the SRA Funds Investor Group in late August 2018. The parties met and conferred in telephonic conference calls and in email exchanges. Attached hereto as **Exhibit B** is true and correct copy a portion of an email meet and confer session in which counsel for the SRA Funds Investor Group rejects maintaining the current receivership even if given the opportunity to select a new receiver in favor of the management structure, or something similar, set forth in the SRA Amended Distribution Plan.

4. On or about September 11, 2018, I printed the first page of the website of Uecker & Associates referred to on page 3, footnote 5 of The SRA Funds Investor Group’s Proposed Alternative Distribution Plan. A true and correct copy of that page is attached hereto as **Exhibit C**.
