Successor Receiver Kathy Bazoian Phelps, counsel for plaintiff Securities and Exchange Commission ("SEC"), the SRA Funds Investor Group ("Investor Group"), and Progresso Ventures LLC ("Progresso"), hereby submit this Stipulation and [Proposed] Order (1) Setting Briefing Schedule and Hearing on Receiver's Motion for Approval of Distribution Plan and Related Claims Objections; and (2) Approving Procedures re Selection of Investment Advisory Committee.

STIPULATION

- 1. On February 7, 2020, the Court entered its order requiring the Receiver to circulate to the SEC, counsel for the Investor Group, and counsel for Progresso, a revised draft of the Distribution Plan that is substantially in the form attached as Exhibit "1" to the Receiver's Supplement (Doc. No. 538, starting at p. 33), and ordering the Receiver to meet and confer with the SEC, counsel for the Investor Group and counsel for Progresso, in an effort to obtain mutual agreement as to the contents of the proposed Distribution Plan before filing a motion for final approval of the Distribution Plan. (Doc. No. 562.)
- 2. The Receiver, and counsel for the Commission, counsel for the Investor Group, and counsel for Progresso have conferred and have agreed, subject to Court approval, to set the following briefing schedule and hearing date on the motion for final approval of the Distribution Plan as follows, provided that the Motion be filed no later than February 28, 2020:
 - a. Any opposition to the Motion for Final Approval of the Distribution Plan shall be filed on or before March 16, 2020;
 - b. Any replies shall be filed on or before March 27, 2020
 - c. The hearing on the Motion will be set for April 7, 2020, at 10:30 am.
- 3. The parties have also agreed that any motions objecting to claims filed by either the SEC or the Receiver shall be set for hearing on April 7, 2020 at 10:30 a.m. and that notice shall be provided and the deadlines for oppositions and replies shall apply as set forth in the Local Rules.

1 must be filed on or before March 16, 2020. 2 2. Any replies must be filed on or before March 27, 2020. 3 3. A hearing shall be held at 10:30 am on April 7, 2020. 4 4. A hearing on any motions objecting to claims shall be held at 10:30 a.m. on April 7, 5 2020 and notice shall be provided and the deadlines for oppositions and replies shall 6 apply as set forth in the Local Rules. 7 5. Any investors who wish to submit an application to serve on the Investment Advisory 8 Committee ("IAC") shall submit an application to the Receiver by March 9, 2020. 9 Those already identified by the Investor Group need not resubmit applications, as set 10 forth in the Court's February 7, 2020 Order and the proposed Plan. 11 6. If the parties cannot agree on the members who will serve on the IAC, the Receiver 12 shall file a request for instructions on who shall serve on the IAC by March 16, 2020. 13 7. Any responses to the Receiver's request for instructions shall be filed on or before 14 March 23, 2020 15 8.
